



Nuckolls County Board Minutes



JULY 10, 2017 PROCEEDINGS OF THE NUCKOLLS COUNTY BOARD OF COMMISSIONERS

The Nuckolls County Board of Commissioners met Monday, July 10, 2017 in the Board Meeting Room at the Courthouse, Nelson, Nebraska, per recess of July 3, 2017. Christensen, Zikmund and Blackstone present for the meeting. The agenda of said meeting was remitted to board members in advance of the meeting and is posted in the County Clerk's office and on the County Website. Chairman Zikmund announced the 'Open Meetings Act Law' as posted in the Commissioners Board Meeting Room and handouts are available.

The board reconvened at 8:30 a.m. A motion was made by Christensen approve the Agenda and the July 3, 2017 minutes with an adjustment. Seconded by Blackstone. Blackstone, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.

The board had advertised requesting bids for the replacement of the 800 amp electrical panel and 2 smaller 200 amp panels in the courthouse basement. Bids were submitted by; Drudik's Electric, Inc for \$12,800.00, Energized Electric Co. for \$8,800.00 or \$9,200.00 and South Central Electric, LLC for \$9,268.85 or \$9,968.95. **A motion was made by Christensen to accept the bid of \$9,200.00 from Energized Electric Co. Seconded by Christensen. Blackstone and Christensen voted aye, Zikmund voted nay. Motion carried.**

Warren and the board discussed the semi & trailer accident that had occurred July 5, 2017, where one of the road department employees was run off the road in the north part of the county. Warren explained to the board that he was working with Nirma to get damages repaired as soon as possible.

County Attorney Bockstadter and Sheriff Baker joined the meeting while Miller and Rogers explained to the board that they had been notified that the current insurance carrier United Health Care didn't agree with the Nuckolls County handbook stating 24 hours a week or 100 hours a month requirement for insurance eligibility. Bockstadter stated that she reviewed the guidelines of the Affordable Health Care Act and did not see an issue, but agreed to make an amendment to the handbook changing the eligibility standards from 24 hours a week or 100 hours a month to 30 hours a week or 120 hours a month. **A motion was made by Blackstone for County Attorney Bockstadter to amend the hours of insurance eligibility in the Nuckolls County Employee Handbook. Seconded by Zikmund. Blackstone and Zikmund voted aye, Christensen voted nay. Motion carried.**

A motion was made by Zikmund to Accept the Monthly Board Reports from the County Treasurer, County Clerk, Clerk of the District Court, County Court and County Sheriff as submitted. Seconded by Christensen. Blackstone, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.

Chairman Zikmund adjourned the regular Board Meeting at 10:00 a.m. to enter Board of Equalization meeting.

There being no further business the meeting was adjourned at 10:00 a.m. until Monday, July 17, 2017.
