NOVEMBER 6, 2017 PROCEEDINGS OF THE NUCKOLLS COUNTY BOARD OF COMMISSIONERS

The Nuckolls County Board of Commissioners met Monday, November 6, 2017 in the Board Meeting Room at the Courthouse, Nelson, Nebraska, per recess of October 23, 2017. Christensen, Zikmund and Blackstone present for the meeting. The agenda of said meeting was remitted to board members in advance of the meeting and is posted in the County Clerk's office and on the County Website. Chairman Zikmund announced the 'Open Meetings Act Law' as posted in the Commissioners Board Meeting Room and handouts are available.

The board reconvened at 8:30 a.m. A motion was made by Blackstone approve the Agenda and the October 23, 2017 minutes. Seconded by Christensen. Blackstone, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.

Gary Warren, Highway Superintendent, and Cindy Buescher, Executive Secretary, met with the Board to give the weekly update on the road department. Their discussion included; hauling gravel for winter stock, mowing is about half done, dirt crew is working on driveway tubes, going to start Project #704-#705-#706 North of Ruskin, and tree removal. Warren presented the options researched regarding the dirt blowing on the Aurora Coop road. Warren said that the soybean oil option wasn't a good option but was looking into a tree sap treatment that had been used by another county. Warren also informed the board he had received 3 applications for the recently advertised Road Department position.

A motion was made by Blackstone to Approve an Easement for Electrical Line for Randy Lemke NE of 12-T3-R9W in to NW 7-T3N-R8W. Seconded by Christensen. Blackstone, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.

A motion was made by Christensen to accept the Monthly Board reports of the County Clerk, County Court, Sheriff, County Treasurer and Clerk of the District Court as submitted. Seconded by Blackstone. Blackstone, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.

Susan Rogers on behalf of the Insurance Committee presented a drafted letter to the Nuckolls County Dental providers asking them to join the Delta Dental PPO. The board approved the letter.

Nick Elledge presented the board with the decals selected for the Emergency Management/Noxious Weed vehicle. Elledge also informed the board he would be out of the county next week to the NACO Noxious Weed conference that would count towards some of his required yearly hours training.

Treasurer Ensign, Assessor Rogers, District Court Clerk Gonzales all joined the meeting to start the 2019-2022 Elected Official Salary discussions. Nebraska Association of County Officials 2017 Minimum Salary Recommendations Report and Supplemental Information was released, and is available for review. This report gathers data from all 93 Nebraska counties and spits them into 6 categories according to population, land value, levy, and migration, and compiles a recommended salary for elected officials. Nuckolls County is a category 2 the \$48,600.00 to \$67,700.00 range. The current Resolution's final salary in 2018 is \$42,108.00. According to the NACO report Nuckolls County's Elected Officials are ranked 11th lowest and Board of Commissioners are 41st out of 93 counties. Discussions will continue in future meetings as the board will need to set 2019-2022 salaries per state statute before January 15, 2018.

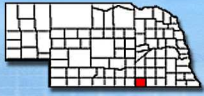
