DECEMBER 4, 2017 PROCEEDINGS OF THE NUCKOLLS COUNTY BOARD OF COMMISSIONERS

The Nuckolls County Board of Commissioners met Monday, December 4, 2017 in the Board Meeting Room at the Courthouse, Nelson, Nebraska, per recess of November 27, 2017. Christensen, Zikmund and Blackstone present for the meeting. The agenda of said meeting was remitted to board members in advance of the meeting and is posted in the County Clerk's office and on the County Website. Chairman Zikmund announced the 'Open Meetings Act Law' as posted in the Commissioners Board Meeting Room and handouts are available.

The board reconvened at 8:30 a.m. A motion was made by Blackstone approve the Agenda and the November 27, 2017 minutes. Seconded by Zikmund. Blackstone, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.

Gary Warren, Highway Superintendent, and Cindy Buescher, Executive Secretary, met with the Board to give the weekly update on the road department. Their discussion included; the guys are working on driveway tubes, cutting trees and working on signs, working on Road 3500 between Road Q and Road PQ, phone line on Projects #704, #705 & #706 is starting this week, working on Road 3400 between Road M and Road N for the new house, and Bridge #C006535025 Southwest of Hardy. Warren informed the board he would like to purchase a gas powered post pounder for \$2,500.00, the board agreed.

A motion was made by Blackstone to accept the Monthly Board reports of the County Clerk, County Court, Sheriff, County Treasurer and Clerk of the District Court as submitted. Seconded by Zikmund. Blackstone, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.

A motion was made by Zikmund for the board to sign Resolution Pledged Security Release presented by Nuckolls County Treasurer Ensign. Seconded by Christensen. Blackstone, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.

Nick Elledge explained to the board that he had attended a flood plain meeting.

Nuckolls County Public Defender, Ben Murray had sent the board a letter concerning the Public Defender Contract expiring December 31, 2017. This is a two year contract for \$2,500.00 a month. Murray expressed interest of another two year contract but at \$3,000.00 a month due to the increasing work load for Nuckolls County Courts. **A motion was made by Christensen to continue receiving services from Murray. Seconded by Zikmund. Blackstone, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.** Miller will contact Murray concerning the new contract.

A motion was made by Blackstone to Designate Voter Registration for Nuckolls County at the December 2017 NACO Election. Clerk Carrie Miller being first designated and Assessor Susan Rogers being second designated. Seconded by Zikmund. Blackstone, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried. This is an election for NACO representatives that will take place at the December 2017 NACO Conference. Miller or Rogers will cast the vote on behalf of Nuckolls County in the event the Chairman of the Board is absent.

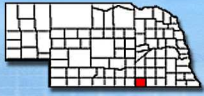
