

PRESS RELEASE

Nuckolls County has made decisions regarding the safety, services, and organization within the County Courthouse. We will follow closely the Federal and State Guidelines for controlling the COVID-19 (Coronavirus). Please understand these guidelines may change rapidly. We will do our best to communicate changes to the media as decisions are made.

The Nuckolls County Board of Commissioners met for an Emergency Meeting of the Board on March 18, 2020 at 3:00 PM. For the safety of the staff and public, the following changes will be implemented on Wednesday, March 18th, 2020 at 4:30 PM:

1. All walk in members of the public will be limited to entry into the Courthouse, Extension Officer, and Highway Roads Department by appointment only with exception to the those entering for scheduled court proceedings or scheduled, either regular or special, or emergency meetings of the Nuckolls County Board of Commissioners.
2. All members of the public entering the Courthouse for scheduled court proceedings shall be restricted to use of the South entrance with the exception of the necessity for handicapped access which shall be restricted to use of the North entrance.
3. All members of the public entering the Courthouse for Nuckolls County Board of Commissioners meetings shall be restricted to use of the North entrance.
4. All other members of the public are required to contact the office or offices which they are needing to visit for the purpose of scheduling appointments. Such limited access shall be permitted only after passing a screening process to determine whether such access should be denied based upon current health screening protocols.
5. All scheduled appointments for the Nuckolls County Clerks Office, Nuckolls County Veterans Services Office, Nuckolls County District Court Clerk Office, and Nuckolls County Attorney Office shall be restricted to use of the North entrance.
6. All scheduled appointments with the Nuckolls County Treasurers Office and Department of Motor Vehicles shall be restricted to use of the East entrance with the exception of the necessity for handicapped access which shall be restricted to use of the North entrance.
7. All scheduled appointments with the Nuckolls County Assessors Office, Nuckolls County Court Office, and Nuckolls County Emergency Manager Office shall be restricted to use of the South entrance with the exception of the necessity for handicapped access which shall be restricted to use of the North entrance.
8. The County is strongly recommending the use of online services or services through the postal service whenever possible. Please refer to the Nuckolls County Website or contact a Nuckolls County Official for available services.

9. County and District Court will continue as scheduled at this time. Any questions with regard to County or District Court should be directed to the respective offices.
10. All access to the Nuckolls County Courthouse will be restricted to the prior schedule appointment purpose, scheduled Court proceedings, or meetings of the Nuckolls County Board of Commissioners.
