Please register by February 28th 2025. There is a non-refundable \$25.00 registration fee for each company/individual who attends our tax sale. A check for the registration fee along with this form and a W-9 is required upon registration. The tax sale listing can be found at our county website nuckollscountyne.gov. This website will NOT be updated. A current listing of the available properties will be given out the morning of the sale.

RE: "Notice of Administrative service fee" Neb. Rev. Stat. 77-1818(2)

The purchaser shall notify the county treasurer of the amount of such fee within thirty days after completion of the service of notice. We will accept a receipt showing the completion of personal service and at that time we will enter the administrative fee equal to the greater of one hundred dollars or the actual cost. If the certificate has already been redeemed before we have received your receipt, we will not be liable to collect your administrative fee. Please do not send notices of administrative fees before service has been perfected upon the property owner.

RULES FOR PURCHASE OF DELINQUENT REAL PROPERTY TAXES:

SALE WILL BE CONDUCTED IN A ROUND ROBIN FORMAT:

The County Treasurer will draw a number for each registered investor, then #1 will choose their first parcel they would like; then #2 and so on; then when all numbers have picked a parcel; we will start with #1 again and continue until all parcels have been chosen.

PLEASE READ ALOUD the parcel number and amount (~~1595.00~~ for \$3,362.92)

LEAVE A BLANK CHECK AND TAX ID NUMBER
COPIES OF THE TAX SALE CERTIFICATES, RECEIPTS AND OF THE CHECK
WILL BE MAILED TO THE COMPANY.
